RE: Amend Ordinance 10.04.010 Adding 25 MPH Speed Limit on Main Street in Coulterville

RECOMMENDED ACTION AND JUSTIFICATION:

Waive the Second Reading and Adopt an Ordinance to Amend County Code Section 10.04.010 to Include an Additional Speed Limit Designation.

The additional speed limit will be on Greeley Hill Road and/or Main Street from the Intersection of Dogtown Road Westerly to the Intersection of Highway 49 North: Twenty Five Miles Per Hour.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors has a long history of regulating speed in highly used pedestrian and commerce corridors in order to deliver safety to pedestrians and vehicles alike.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Posted speed limits will not be enforceable under Code.

MARIPOSA COUNTY ORDINANCE NO. 1149

AN ORDINANCE AMENDING SECTION 10.04.010 OF CHAPTER 10.04 OF THE MARIPOSA COUNTY CODE ENTITLED "MAXIMUM SPEED LIMIT ON DESIGNATED ROADS"

WHEREAS, the Board of Supervisors desire to regulate vehicular traffic and speed in order to deliver safety for pedestrians and vehicle alike, and

WHEREAS, the Board of Supervisors desire to insure safety and regulate commercial and areas of commerce that are safe for pedestrian and vehicle use, and

WHEREAS, this amendment will add language to reduce the speed limit on Greeley Hill Road and Main Street between the intersections of Dogtown Road and Highway 49 North,

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:


Section I: Section 10.04.010 of Chapter 10.04 of the Mariposa County Code is hereby amended to read as follows:

10.04.010 Sections of Greeley Hill Road and or Main Street between the intersections of Dogtown Road and Highway 49 North in Coulterville: twenty five miles per hour.

Section II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code §25123.


