RE: Amend Section 10.08.020 of the County Code

RECOMMENDED ACTION AND JUSTIFICATION:

Waive the Second Reading and Adopt an Ordinance Amending Section 10.08.020 of the County Code Titled "Stopping, Parking, or Standing Prohibited" to Add Section "R" Which is Proposed to Read as Follows "On Both Sides of Lazo Way from Zarzo Way in Both Directions to Coronado Drive".

BACKGROUND AND HISTORY OF BOARD ACTIONS:

This ordinance was introduced on August 18th, 2020.

Given a recent fire this area had become a hazard area through it's attraction of individuals to it's remoteness to park and set off fireworks and engage in other detrimental activities that compromise public health and safety both to the adjacent residential community and the transportation system.

Public Works has been working with the neighbors, Sheriff and Fire Departments, to craft a solution that will eliminate the Fire and Health hazards associated with the vehicular parking in this area.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Should this not pass the Sheriff's Office will be devoid of an ability to cite these vehicles for the proposed parking violation and the activities which have been deemed detrimental to public health and safety will continue.

MARIPOSA COUNTY ORDINANCE NO. 1155

ORDINANCE AMENDING SECTION 10.08.020 OF THE MARIPOSA COUNTY CODE

WHEREAS, the Board of Supervisors desire to regulate vehicular traffic, speed and parking in order to deliver a safe transportation environment for residents, pedestrians and vehicles alike, and

WHEREAS, the Board of Supervisors desire to eliminate activities that prove to be detrimental to safe traffic vehicular movement devoid of unanticipated or unrecognizable traffic hazards, and
WHEREAS, the Board of Supervisors desire to protect healthy and safe transportation corridors within the County Transportation System, and

WHEREAS, this amendment will add language to eliminate the Stopping, Standing or Parking on Both Sides of the roadway located on Lazo Way from Zarzo Way in Both Directions to Coronado Drive.
NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows


SECTION I: Section 10.08.020 of Chapter 10 of the Mariposa County Code is hereby amended to read as follows:

R. On Both Sides of Lazo Way from Zarzo Way in Both Directions to Coronado Drive.

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code §25123.
