RE: Appointment of Planning Commissioner for District II (Supervisor Sweeney)

RECOMMENDATION AND JUSTIFICATION:

Appoint Leo J. (Jack) Wilmeth as Planning Commissioner, Representing District II for a Term Coinciding with the Term of District II Supervisor Expiring January 6, 2025 (Supervisor Sweeney).

This action is based on the recommendation of the District II Supervisor who, under County Code Section 2.52.030, nominates one or more candidates to represent his or her district for appointment by the board of supervisors.

Mr. Wilmeth meets the qualifications for a Planning Commissioner as established by County Code Sections 2.52.010 and 2.52.020. He resides within District II, is a qualified elector of Mariposa County and has expressed interest in serving on the Mariposa County Planning Commission.

This position has been advertised according to the Maddy Act.

Notifications of vacancy were first posted on November 3, 2020, reposted on November 16, 2020 (due to an error) and again posted on January 12, 2021.

Since the most recently posted notice of vacancy on January 12, 2021, a total of three applications have been received for this position: Leo J. (Jack) Wilmeth, Shannon Poe and James Rhodes.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors appoints Planning Commissioners upon the nomination of the District Supervisor.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not appoint District II Supervisor's nominated candidate and leave District II without representation on the Planning Commission.

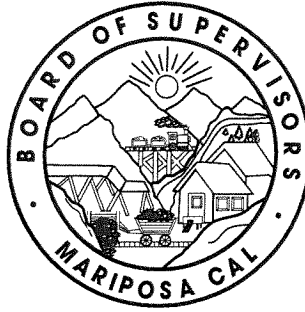
