RE: Approve Amended CDPH Immunization Assistance Program Grant

RECOMMENDATION AND JUSTIFICATION:

Approve an Amendment to the California Department of Public Health (CDPH) Immunization Local Assistance Grant Agreement Number 17-10329, A02 to Increase the Grant Funding by \$39,696 for a New Amount Not to Exceed of \$73,771 for Fiscal Year 2020-2021 and Increases the Total 2017-2022 Grant Funding to the New Amount Not to Exceed \$214,421; and Authorize the Health and Human Services Agency Director to Sign the Amendment.

The purpose of this Grant Amendment is to increase funding for Fiscal Year 2020-2021 in the amount of \$39,696 to augment and enhance efforts around influenza vaccination coverage as well as perform Corona Virus Disease 2019 (COVID-19) vaccination planning and implementation.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On March 17, 2020 the Board of Supervisors approved Resolution #2020-130 Amendment to the Immunization Local Assistance Grant Agreement #17-10329 01 which decreased funding by \$6,525 for Fiscal Years 2019-2022 due to federal budgetary constraints.

On May 9, 2017, Mariposa County Health Department submitted the CDPH Immunization Local Assistance Immunization Local Assistance Grant Application for Fiscal Year 2017-2022. On February 21, 2018 the Health Department was notified that the application was accepted and was awarded the contract for Fiscal Year 2017-2022 in the amount of \$181,250 (\$36,250 per Fiscal Year).

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If the Board chooses not to authorize this amendment, the Agency will forfeit additional grant funding for Fiscal Year 2020-2021.

FINANCIAL IMPACT:

This amendment will increase revenue to perform activities. There is no financial impact to the general fund with this amendment.
