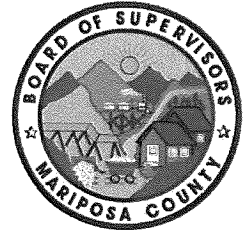

TO: The Board of Supervisors

RE: Declare Surplus Property and Authorize Sale and Disposal

RECOMMENDATION AND JUSTIFICATION:

Declare the Items Listed in the "Auction / Retired Vehicles and Equipment List (04/2021)" as Retired or Surplus Equipment; and Authorize the Director Public Works & Transportation to Direct the Sale and Disposal of These Items at Public Auction and Deposit Any Net Proceeds Received in the Appropriate Vehicle Replacement.

From time to time staff will seek authority to sell at auction rolling stock assets that no longer meet the demands of the various Department's Mission and where it is no longer wise or prudent to invest in continued mechanical repairs. The attached list details those items that staff wishes authorization to sell at auction.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has allowed this practice in the past and determined that public auction is in the best interest of the County to dispose of these items.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Should this item not be approved these items will have to be stored at Public Works and they will continue to lose resale value over time.

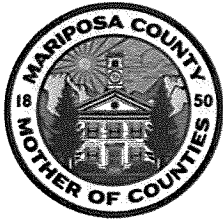
