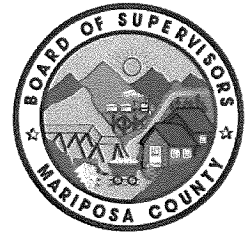

RECOMMENDATION AND JUSTIFICATION:

Schedule Five Public Hearings and two Special Meetings for the Redistricting Process.

On May 11, 2021, during a discussion regarding the 2021 Redistricting process, the Board gave direction to schedule a series of public hearings and two special meetings for the accomplishment of the redistricting process. The public hearings and meetings being scheduled with this action are:

PUBLIC HEARING #1: Tuesday, June 8, 2021 at 2:00 PM

PUBLIC HEARING #2: Saturday, July 10, 2021 at 10:00 AM (Special Meeting)

PUBLIC HEARING #3: Tuesday, September 14, 2021 at 2:00 PM

PUBLIC HEARING #4: Monday, November 1, 2021 at 6:00 PM (Special Meeting)

PUBLIC HEARING #5: Tuesday, November 2, 2021 at 2:00 PM

Under the Brown Act, as well as the Board's adopted Rules of Procedure, special meetings may be called by either the Chair, by the Vice-Chair in the Chair's absence, or by concurrence of the Board.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

May 11, 2021: The Board received a presentation on the redistricting process and concurred with the public hearing and meeting schedule that was proposed. This action is to fulfill the Board direction given on that date.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

The County will be out of compliance with redistricting laws if the Board chooses to not approve scheduling hearings and meetings for that purpose. The Board may suggest alternate dates, but would need to align a final schedule to the mandated requirements.
