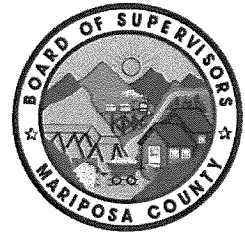

RE: Approve Budget Action for FY21 Budget to Purchase Fixed Asset

RECOMMENDATION AND JUSTIFICATION:

Approve Budget Action Transferring Funds Within the Sheriff's Department Fiscal Year 2021-2022 Budget to Allow the Purchase of a Fixed Asset - Mobile Repeater (\$14,951).

The Sheriff's Office has purchased a Mobile Repeater to allow for better radio communications for patrol and rescue units in remote areas of Mariposa County.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

All budget actions to purchase fixed assets require Board review and approval.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this budget action is not approved there will be continued limited or no radio communications in remote areas of Mariposa County. This will limit and/or delay patrol and rescue units in the course of their assigned duties.

FINANCIAL IMPACT:

There is sufficient funding in the Sheriff's Office budget to accommodate the cost of the mobile repeater. There is no impact to the County General Fund.
