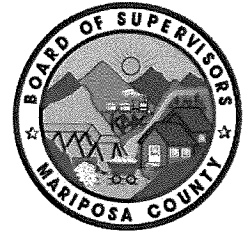

## RESOLUTION - ACTION REQUESTED 2021-509

RE: Kings View Corporation MIS Agreement with Health and Human Services Agency

### RECOMMENDATION AND JUSTIFICATION:

Approve an Agreement with Kings View Corporation to Provide Electronic Health Record Information System Technical Support and All Pay Sources Billing Services to Health and Human Services Agency (HHSA) in an Amount Not to Exceed \$172,039; and Authorize the Board of Supervisors Chair to Sign the Agreement.

Kings View provides extensive support and hosting of the Anasazi Electronic Health Record Information System that is essential to the operation of Mariposa County HHSA's Health Services division. It is more cost efficient for the County to contract with Kings View to support the Anasazi system than attempt to duplicate their services. The costs for additional qualified Information Technology (IT) personnel, information security, and equipment would exceed the costs of this contract.

HHSA Behavioral Health is transitioning to a new Electronic Health Record Information System (EHR) "InSync." The purchase was approved by the Board on December 10, 2019 by Resolution 2019-692. The InSync system has been used for our services data entry since August 2020 and in the future; however, our legacy data hosting and other supports during InSync development are provided by Kings View. HHSA wishes to continue the agreement with Kings View until the InSync development is complete and the hosting of legacy data is resolved. Legacy data must be retained at least 7 years for audits.

### BACKGROUND AND HISTORY OF BOARD ACTIONS:

The most recent agreement was approved by the Board on July 28, 2020 by Resolution 2020-445. The Agency has contracted with Kings View for these services since 2004.

### ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this Agreement is not approved, the Health Services division would be without historical information required for the electronic health record transition and for audits and would be unable to complete any final billing associated with these services.

### FINANCIAL IMPACT:

**The cost of this agreement is spread over three or more budget units (Behavioral Health, Alcohol & Drug, and Mental Health Services Act, etc.) based on number of staff assigned to each unit and is incorporated in the FY21-22 budget. There is no impact to the General Fund.**
