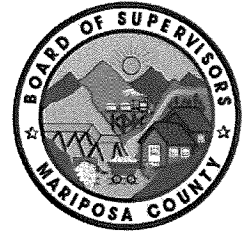

RE: Appoint Members to the Airport Advisory Committee (AAC)

RECOMMENDATION AND JUSTIFICATION:

Appoint Gary Friesen to Fill a Vacancy in Category "A" on the Airport Advisory Committee with a Term Expiring January 6, 2025; and Appoint Caleb Chaney as an Alternate Member to Fill an Unexpired Term Ending January 3, 2022, as Recommended by Board Liaisons Supervisors Long and Menetrey.

The AAC was established as an advisory group to the Mariposa County Planning Commission and the Board of Supervisors. The AAC provides advice and recommendations on the preparation and adoption of an airport comprehensive use plan, land use projects in the Mt. 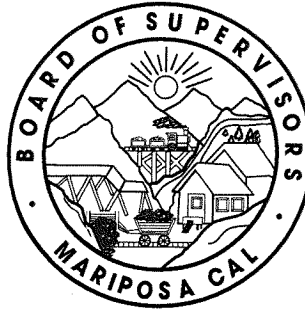

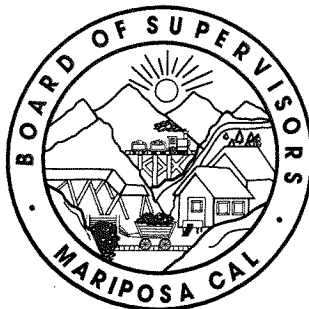
