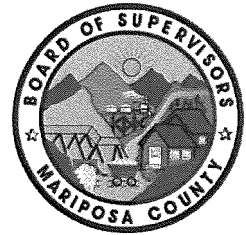

RESOLUTION - ACTION REQUESTED 2021-555

MEETING: October 5, 2021
TO: The Board of Supervisors
FROM: Shannon Gadd, Health and Human Services Agency Director
RE: Second Amendment - Agreement with JDT Consultants, Inc.

RECOMMENDATION AND JUSTIFICATION:

Approve Second Amendment to Agreement with JDT Consultants, Inc., increasing the agreement amount by \$6,000 to a new amount not to exceed \$106,000; and authorize the Board of Supervisors Chair to sign the amendment.

During the term of our FY2021 agreement, the demand for TBS services from JDT Consultants has been greater than anticipated.

JDT Consultants provides Therapeutic Behavioral Services (TBS) to Mariposa County children/youth who are eligible for Medi-Cal, meet criteria for TBS services and are referred by Mariposa County Health and Human Services Agency (HHSA). TBS is an intensive, one to one, face to face, short term outpatient treatment intervention for individuals under the age of 21 with serious emotional disturbance (SED) who are experiencing a stressful life transition or life crisis and need additional, short term, specific support services. These services shall be available to children with difficult behaviors who require one to one assistance and who may be at risk of psychiatric hospitalization or in need of preservation of placement.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The existing agreement with JDT Consultants, Inc. was approved on February 21, 2020 by County Administrative Officer.

The First Amendment was approved by the Board of Supervisors on January 5, 2021 through Resolution No. 2021-7.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this Amendment is not approved, the Agency will be negatively impacted in providing vital services to this specific target population within Mariposa County.

FINANCIAL IMPACT:

These contract expenses are budgeted in the HHSA Health Services division budgets. These services are claimed to Medi-Cal and costs are offset by revenue received. There is no impact to the County General Fund.

SECOND AMENDMENT TO AGREEMENT FOR THERAPEUTIC BEHAVIORAL SERVICES

THIS SECOND AMENDMENT TO AGREEMENT FOR THERAPEUTIC BEHAVIORAL SERVICES, is made and entered into this 5th day of October 2021, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as “**County**,” and JDT Consultants, Inc., hereinafter referred to as “**Contractor**.”

WHEREAS, County and Contractor have heretofore entered into an Agreement dated February 21, 2020, wherein **Contractor** agreed to provide therapeutic behavioral services; and

WHEREAS, County and Contractor have heretofore entered into a First Amendment dated January 5, 2021, wherein the compensation was increased from \$50,000 to \$100,000; and

WHEREAS, County and Contractor desire to amend said Agreement to change the compensation to be provided to **Contractor**;

NOW THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 2, “COMPENSATION” and Exhibit B, “COST PROPOSAL” are hereby amended to provide that additional \$6,000 will be added to the amended amount of \$100,000, making the total compensation paid to Contractor the not to exceed amount of \$106,000.

Except as herein amended, the Agreement dated February 21, 2021, together with the First Amendment dated January 5, 2021, shall remain in full force and effect.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in this Agreement not amended herein shall remain in full force and effect. This Amendment is effective retroactive to June 30, 2021. The parties shall treat the Agreement as if it had been in full force and effect continuously since June 30, 2021, without there having been any interruption of the Agreement whatsoever.


