Submittal Requirements: *Please be advised that ALL required information must be attached for the Temporary Housing Permit Application and submitted prior to issuance of a Temporary Housing Permit.*

Location of Temporary Housing: On-site or Off-site

Application Form – Complete and signed by all parties

Site Plan - Provide a detailed site plan of the parcel including the following information:

- a. Property lines and dimensions of the parcel.
- b. Approximate boundary of burn area on-site (if applicable).
- c. Location of all creeks, springs, intermittent streams, other drainages and lakes or reservoirs on the property.
- d. Location, size and dimensions of all existing (or existing prior to fire) structures, including power pole(s).
- e. Location of existing (or existing prior to fire) sewage disposal systems on the property.
- f. Location of all existing (or existing prior to fire) well sites on the property.
- g. Location of temporary RV or trailer

(Note: If the temporary RV or trailer is proposed to be located within the burn area, the RV or trailer must be located outside the location of the future permanent replacement housing and outside of the burn zone cleanup area in a manner that does not impede the debris removal process. The temporary RV or trailer shall be located a safe distance from the footprint of any damaged structure as approved by Health and Human Services Agency-Environmental Health Unit (HHS-A-EHU) on a case-by-case basis (may require Phase 2 clean-up to be completed).
